



MARKET LIVESTOCK REGISTRATIONS

- When completing your forms, be sure to completely fill out your forms and have them signed. Make sure if you have an e-mail you put it here as this will be our primary way to connect with exhibitors. Make sure your parent's names are listed as you would like to see them in our sale catalog.
- SCRAPIE ID tag numbers will be closely looked at on all of our sheep and goat registration forms and are required by the Michigan Department of Agriculture and Rural Development for all goat and sheep animals at the fair.
- We will need to have one picture of the entire animal and a picture of the ear tag clearly visible for each animal. You can include more than one picture per animal. Staple pictures to the back of your form.
- Each form *must* a picture of all animals *even if they are on other forms*.
- **FAXED REGISTRATION FORMS WILL *NOT* BE ACCEPTED.** They will not provide photos and are difficult to read. The fair will accept mailed, emailed to info@gcffy.org or delivered to Gratiot County Fair for Youth or MSU Extension.
- Incomplete registration forms will ***NOT*** be accepted.
- Exhibitors may register up to four market goats.
- Showmanship is mandatory for all exhibitors.
- Market Livestock Financial Sheets are **NOT** required for Small Animals.

2017 Market Goat Class Rules

DEPARTMENT 8 - Goats

- Market goats may only be wethers and does. No bucks will be allowed to exhibit as market goats.
- All market goats must be identified with a GCFFY Ear Tag purchased from the fair office and registered with pictures on the official form by May 15.
- Market goats must still have their milk (baby) teeth at time of show.
- Market goats consist of purebred or percentage meat breed goats, dairy cross goats, or dairy breed goats.
- If a doe is shown in Market class, it cannot also be shown in a breed class.
- Market goats must weigh a minimum of 35 lbs. to sell. A market goat may be re-weighed the day after check-in if it is underweight.
- All market goats must sell. See Small Animal Sales Rules near the front of the fair book.

Changes and corrections may be made and will be printed in the fair book. Refer to fair book for official rules. If there are changes made after the printing of the fair book, the fair will contact each exhibitor who has registered with a market goat animal.

- I must attach photograph(s) of each animal to this form. The photograph must show the body of the animal and the fair's ear tag clearly pierced in the animal's ear with numbers readable. If this can not be done in one photo, additional photo(s) must be added.
- I may only sell one animal at the large livestock sale.
- Forms not COMPLETELY filled out and with photographs attached will NOT be accepted.
- By completing this form, I agree to allow a GCFY board member or Species Superintendent to do a visual farm check to verify information in this form. Refusal to allow this visit will result in disqualification.
