



MARKET LIVESTOCK REGISTRATIONS

- When completing your forms, be sure to completely fill out your forms and have them signed. Make sure if you have an e-mail you put it here as this will be our primary way to connect with exhibitors. Make sure your parents' names are listed as you would like to see them in our sale catalog.
- RFID numbers will be closely looked at on all of our beef and feeder registration forms.
- We will need to have one picture of the entire animal and a picture of the ear tag clearly visible for each animal. You can include more than one picture per animal. Staple pictures to the back of your form.
- Each form *must* a picture of all animals *even if they are on other forms*.
- **FAXED REGISTRATION FORMS WILL NOT BE ACCEPTED.** They will not provide photos and are difficult to read. Emailed registrations are accepted.
- Incomplete registration forms will **NOT** be accepted.
- Market animals must be judged in market class and shown in showmanship to be eligible for the sale.
- Showmanship is mandatory for all exhibitors.
- Exhibitor must complete a Market Livestock Financial Sheet.

2018 Market Beef Class Rules

SECTION A – Market Beef

- Market beef animals must be tagged, photographed, and pre-registered with the Fair Office by February 15.
- Cattle must weigh at least 950 lbs. at weigh-in to be sold at fair.
- Cattle with horns will not be accepted. No stags accepted. Fair board decision final!
- Market animals may be steers or heifers.
- If the animal has lost a GCFFY ear tag or RFID tag, the exhibitor must contact the office immediately and one of the superintendents or a fair board member will re-tag the animal. It will be the responsibility of the exhibitor to re-take the animal's picture with the new ear tag in its ear.
- Refer to General Large Livestock, Large Livestock Sale, and Health Requirement Rules.
- Beef Market classes are decided by weight of animal at time of weigh in.
- All cattle must be tied, NO PENS ALLOWED.

Changes and corrections may be made and will be printed in the fair book. Refer to fair book for official rules. If there are changes made after the printing of the fair book, the fair will contact each exhibitor who has registered with a market beef animal.

Deadline is February 15, 2018

An exhibitor may tag up to four beef animals and one animal must be declared as your primary animal. All animals may be registered by exhibitors who are in your IMMEDIATE family but the primary animal on your form must be listed as a secondary on another form. FAXED FORMS WILL NOT BE ACCEPTED.

- I must use an ear tag purchased this year from Gratiot County Fair for Youth for each animal registered.

- The fair has up to eight weeks after the close of fair to mail sale checks.
- I must attach photograph(s) of each animal to this form. The photograph must show the body of the animal and the fair's ear tag clearly pierced in the animal's ear with numbers readable. If this can not be done in one photo, additional photo(s) must be added.
- I may only sell one animal at the large livestock sale.
- Forms not COMPLETELY filled out and with photographs attached will NOT be accepted.
- By completing this form, I agree to allow a GCFY board member or Species Superintendent to do a visual farm check to verify information in this form. Refusal to allow this visit will result in disqualification.
- I must complete a GCFY Market Livestock Financial Sheet.
